Just a friendly reminder that we will order digital vouchers and load Gift-Cards on Wednesday 1 July 2020 for the month of July.

We are busy closing registrations and will not be able to support additional members.

Overview

A total of 99 Shareholders are now ready to participate in the Gift-Card process scheduled for 1 July. Shareholders will be constantly updated until the orders have been completed.

Shoprite, Checkers and USave

Orders are open and you pledged to load R1,500

Pick n Pay

Orders are open and you pledged to load R500

Spar

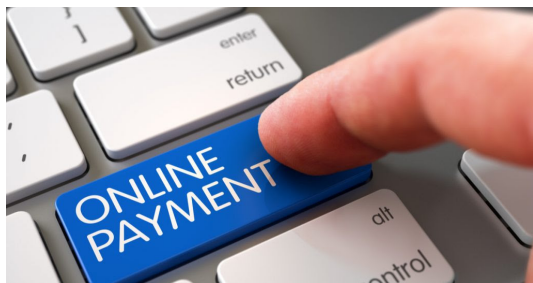
Orders are **CLOSED** although you pledged to load R500

We do not have enough support from our current shareholders to reach the minimum R500 000 bracket before bulk discount became applicable. We are busy to prepare for Beta testing and therefore decided not to include Spar orders for July's order list.

Process after payment was received:

All payments received from Shareholders are shared with the entire team.

You will receive a Payment Confirmation e-mail as soon as your payment reflects in the Homecare FNB account, (This is to confirm that your money will be kept in our Trust account until the entire group's funds can be transferred to the different Retail Head Offices.)

Annelize van der Loo will upload a PDF of the Bank statement when the first payment of any of the shareholders reflects. (This PDF will then be mailed via the software to all the shareholders) From thereon onward, until payments towards Retail Companies has been completed, updates of the bank statements will on a daily basis be mailed to all the shareholders.

Lucia van Wyk will on a daily basis (close of business) also receive the bank statements to

monitor how CVO participants support the project.

On Wednesday at 12H00, the server will close the order list and the Retail Companies will receive the combined orders to be processed. The transfer of the funds into Retail Companies will then be processed. Proof of such payments, plus a copy of the Bank statement after funds has been transferred will again be mailed to all the Shareholders.

Delivery of Vouchers:

Shoprite Group

You will during the course of the week (after payment was completed) receive a digital voucher on your phone to the value of: R1,500

The e-mail with Barcode and the sms you will receive, explain in detail how to transfer the Digital Voucher inside Checkers, Shoprite or USave stores onto plastic gift-cards. You can then swipe these cards when you pay for products or services.

Pick n Pay

Shareholders who already loaded funds onto Pick n Pay cards will use their existing Gift Cards.

Shareholders placing orders for the first time:

You can now visit the nearest Pick n Pay store and ask for a Gift-Card. (if you perhaps struggle with previously disadvantaged people at the tills, just ask them to load R20 onto a Gift-Card. You want to give this Gift-Card to someone)

Most stores will give the card to you without asking any detail. Although the Franchised owned stores often want people to load a small amount so that they can give the card out.

You will anyway use the R20 towards your own groceries. Once you have the card, ***please capture the 16 digits at the back of the Gift-Card onto the form below.***

This data will then be forwarded to Sharon Groenewald at Pick n Pay Head Office Western Cape.

If you cannot get access to such a card before 2 June, do not be concerned. Sharon will load the R500 onto your card as soon as you can provide us the Gift-Card number.

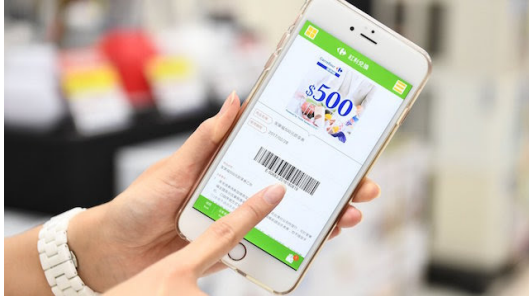
